1. Pre-License Education

- ▶ Course: State-approved 63-hour pre-license course (FREC I) by Cameron Academy
- ▶ Objective: Acquire a comprehensive understanding and fulfill the state requirement.

2. Fingerprinting & Background Check

- ▶ Purpose: Mandatory level two background check by Florida.
- ▶ [Find and Schedule with an approved electronic fingerprinting vendor.](#)

3. Application Process

- ▶ Platform: Florida Department of Business and Professional Regulation (DBPR).
- ▶ Apply on myfloridalicense.com
- ▶ Follow: Home > "APPLY OR MANAGE MY LICENSE" > "REAL ESTATE COMMISSION" > "Apply For A License" > "Real Estate Sales Associates" > "Initial Application Sales Associate License (Form RE 1)"> "Apply Using Online Services" > "Create My Account".
- ▶ Receive a temporary password via email, reset it, then login.
- ▶ Access your application by clicking on your name. Note: Valid for up to 2 years.

4. Cameron Academy Course/Class Exam

- ▶ Location: Accessible through your user account by logging in, visiting your dashboard, opening your registered course, and scrolling to the bottom of the Course Content.
- ▶ 30-day access starting from the 1st day of scheduled class
- ▶ 3-hour test duration, once you click "Start Quiz", the timer will begin.
- ▶ Maximum of 2 attempts, Passing grades: 70% (1st attempt) and 75% (2nd attempt)
- ▶ 30 day waiting period between attempts, course retake required after 2 failed attempts.
- ▶ Certificate added to your [Cameron Academy.com dashboard](#) account after passing. Ensure lessons are marked as complete, certificate validity period: 2 years.

5. Florida State Exam

- ▶ Objective: Last step to licensure.
- ▶ Exam can be scheduled post-DBPR application & background check approval.
- ▶ Use your 9-digit Florida Real Estate Application Identification number (FLREAPPID) to schedule at PearsonVue.com.
- ▶ Search on homepage search tool "Florida Real Estate" > "Florida Real Estate & Appraisers" > "CREATE ACCOUNT".
- ▶ 3.5-hour test duration with a 75% passing grade.
- ▶ Results received at the testing facility. Passes aren't graded; only fails.
- ▶ Reschedule after 24-hour wait if failed, unlimited attempts, but each incurs a fee.
- ▶ Option for a 1.5-hour review of failed tests for an additional fee (within 21 days of fail date).
- ▶ License Activation
